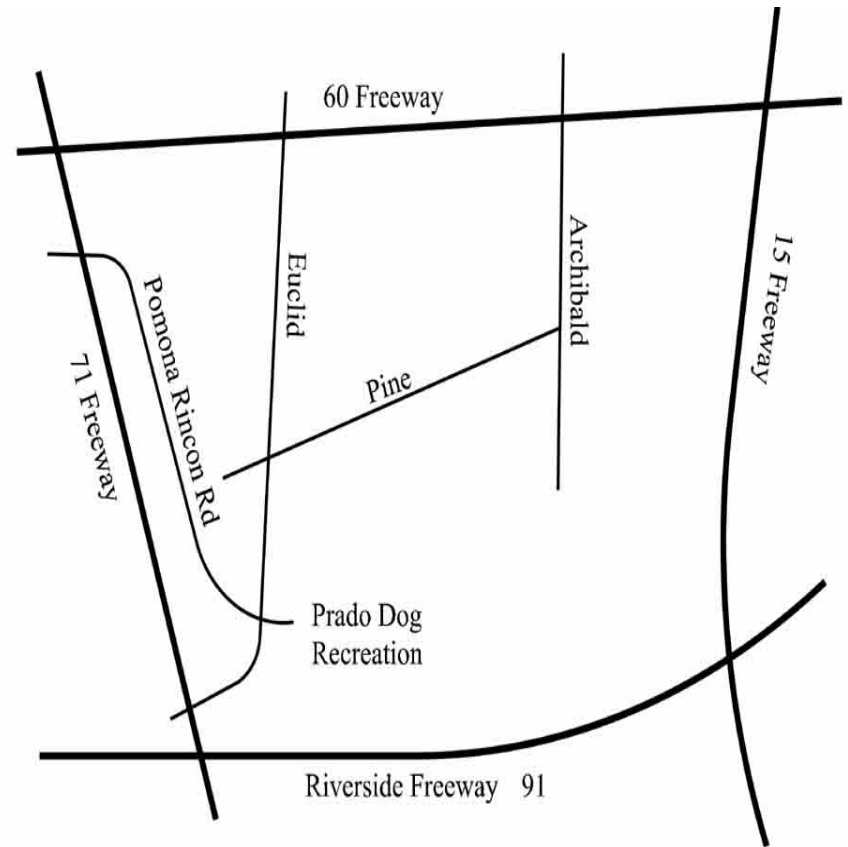

Directions to Prado Dog Training Area, Chino, California

Prado is located on Euclid Avenue (83) before it turns into (71). It is South of Prado Regional Park (the nice lake) and just across (East) of the Prado Shooting Range.

From the South you can take (71) North from the Riverside Freeway (91) to the Euclid exit and then turn right the first time you can turn. From the North on the (60) Freeway, you must take Euclid Avenue (83) South to the entrance. If coming from Northern California on the (5) Freeway, take the (210) Freeway to its end and then South to the (60) Freeway East to Euclid Avenue and then South.
